Ordinance 23/2025 amending and supplementing Government Ordinance no. 15/2002 on the application of the user tariff and the toll on the national road network in Romania

Enters into force:

September 8, 2025

Pursuant to art. 108 of the Constitution of Romania, republished, and art. 1 point VII.3 of Law no. 134/2025 on the empowerment of the Government to issue ordinances ,

The Government of Romania adopts this ordinance .

Art. I

Ordinance no. 15/2002 on the application of the user tariff and the toll on the national road network in Romania, published in the Official Gazette of Romania, Part I, no. 82 of 1 February 2002, approved with amendments and completions by Law no. 424/2002, with subsequent amendments and completions, is amended and completed as follows:

1. In Article 1, after paragraph (3¹), two new paragraphs are inserted, paragraphs (3²) and (3³), with the following content:

"(3²) The level of tolls for the use of the bridge over the Danube between Giurgeni and Vadu Oii, as well as the method of their application, are provided in Annex no. 6, which is an integral part of this ordinance .

(3³) Level of tolls for the use of bridges over the Danube between Fetești and Cernavodă , as well as the manner of their application are provided in Annex No. 7, which is an integral part of this ordinance . "

2. In Article 12², paragraph (2) is amended and will have the following content:

"(2) The level and method of application of the toll for the use of the bridge over the Danube in the Giurgiu-Ruse direction shall be regulated by order of the Minister of Transport and Infrastructure."

3. Article 14 is amended and will have the following content:

"Art. 14

Annexes no. 1-7 are an integral part of this ordinance ."

national roads " is amended and replaced by Annex no. 1, which is an integral part of this ordinance .

5. Annex no. 2 - "Amount of the contravention fine applicable to users in the event of the lack of a valid license plate" is amended and replaced by Annex no. 2, which is an integral part of this ordinance .

Annex no. 4 - "Amount of the contravention fine applicable to users in the event of the lack of a valid toll" is amended and replaced by Annex no. 5, which is an integral part of this ordinance .

7. Annex no. 5 - "List of video cameras at border crossing points or in their vicinity" is amended and replaced by Annex no. 6, which is an integral part of this ordinance .

8. After Annex No. 5, two new Annexes are introduced, Annexes No. 6 and 7, the content of which is provided in Annexes No. 3 and 4, which are an integral part of this ordinance .

Art. II

(1) This ordinance enters into force 10 days after the date of publication in the Official Gazette of Romania, Part I.

(2) User fees and tolls paid prior to the entry into force of this ordinance ISI maintain validity.

Art. III

On the date of entry into force of this ordinance , the provisions of art. 1 para. (4) and (5) of the Order of the Minister of Transport no. 1.836/2018 for the approval of tariffs applied by the National Road Infrastructure Administration Company - SA, with subsequent amendments and supplements, cease to apply.

PART II:

How tariffs are applied

(A) The following vehicles are exempt from paying the toll:

a) owned or, as the case may be, used on the basis of a legal right, according to the data entered in the registration certificate, by:

- I. units of the Ministry of National Defense (MApN);
- II. units of the Ministry of Internal Affairs;
- III. units of the Romanian Intelligence Service ;

- IV. units of the Foreign Intelligence Service ;
- V. Protection Service units and Guard;
- VI. units of the Special Telecommunications Service ;
- VII. Administration National Penitentiary and its subordinate units ;
- VIII. public community services for emergency situations , regulated by Government Ordinance no. 88/2001 on the establishment , organization and the functioning of public community services for emergency situations , approved with amendments and completions by Law No. 363/2002, with subsequent amendments and completions;
- IX. state institutions with responsibilities in security and safety national ;
- X. Company National Road Infrastructure Administration - SA and its subunits ;
- XI. State Inspectorate for Road Transport Control;
- XII. Society National Red Cross of Romania;
- XIII. ambulance services ;
- b) belonging to the Diplomatic Corps and consular transport vehicles, identified by specific registration numbers;
- c) escorted by the police or gendarmerie, who are not subject to control, in the interest of the state or national security ;
- d) specialized, including the vehicles that transport them, which participate in snow removal actions or in calamity situations , natural disasters or in emergency situations caused by special meteorological phenomena communicated by the Administration National Meteorology by code orange or red ;
- e) which transports first aid equipment and humanitarian aid, equipment intended for interventions or vehicles transporting such equipment, within humanitarian missions on the territory of Romania or which transit Romania for humanitarian purposes, at the request of the Department for Emergency Situations within the Ministry of Internal Affairs, based on a collaboration protocol between the two parties that provides for the working methodology, contact points and the modalities of operational communication between the two parties ;
- f) which belong to NATO/SOFA forces , including vehicles belonging to the civilian component, pursuant to Law No. 362/2004 on Romania's accession to the Agreement between the States Parties to the North Atlantic Treaty regarding the Status of their Forces , signed in London on 19 June 1951, and to the Protocol on the Status of International Military Commands established under the North Atlantic Treaty, signed in Paris on 28 August 1952 ;
- g) which belong to NATO/SOFA/ PfP forces , including vehicles belonging to the civilian component, pursuant to Law No. 23/1996 for the ratification of the Agreement between the States Parties to the North Atlantic Treaty and the other States participating in the

Partnership for Peace on the Status of their Forces and the Additional Protocol , concluded in Brussels on 19 June 1995;

h) owned , used by or for the forces of the United States of America, in the interest of the force , vehicles belonging to the civilian component and family members , and vehicles belonging to a third party parties carrying out transport in the interest of the force , pursuant to Law No. 260/2002 for the ratification of the Agreement between Romania and the United States of America on the status of United States forces in Romania, signed in Washington on October 30, 2001, with subsequent amendments and supplements;

i) which belong to NATO/SOFA, NATO/SOFA/ PfP forces , including vehicles belonging to the civilian component, pursuant to Law No. 126/2016 for the ratification of the Supplementary Agreement to the Paris Protocol between the Government of Romania and the Supreme Allied Command Europe and the Supreme Allied Command Transformation, signed in Brussels on 2 December 2015;

j) who belong to an armed force , only on a reciprocal basis, pursuant to Law no. 291/2007 on the entry, stationing , conduct of operations or transit of foreign armed forces on the territory of Romania, republished, with subsequent amendments and supplements;

k) which carries out activities to ensure the protection of public road heritage, current maintenance during summer and winter, road safety works and rehabilitation at the bridge, including the access road, according to the tables approved by the management of the National Road Infrastructure Administration Company - SA through the Constanța Regional Directorate of Roads and Bridges ;

l) cars owned or, as the case may be, used on the basis of a legal right, according to the data entered in the registration certificate, by residents;

m) cars owned or, as the case may be, used on the basis of a legal right by persons with severe or severe disabilities or owned by persons entitled to benefit from free use on behalf of the person with severe or severe disabilities;

n) vehicles intended for school transport , licensed for the activity of transporting people, only during school courses , excluding the holiday period school , Saturday, Sunday and public holidays;

o) vehicles belonging to a third party parts , used in the interest of a military force and which carry out transports in the interest of the Romanian army or a military force , within the framework of an agreement to which Romania is a party.

(B)NOTE:

1. For vehicles from point A letters a)-c) and n) that do not have specific distinctive signs or inscriptions, such as specialized vehicles of the police , gendarmerie, ambulance , fire brigade, those of the Ministry of National Defense (MApN), CD or TC,

proof of inclusion in the payment exceptions is made by presenting the registration certificate or transport documents.

2. The provisions of point A letters f)-j) and o) shall apply based on prior requests submitted by:

a) MAPN, through its own structures;

b) international military structures located on Romanian territory.

The structures mentioned in letters a) and b) are responsible for classifying transports as exempt from paying tariffs.

3. For vehicles from point A letters d) and k), proof of inclusion in the payment exceptions is made by presenting the registration certificate and only in cases announced by the National Road Infrastructure Administration Company - SA through the Constanța Regional Directorate of Roads and Bridges .

4. For vehicles from point A letters l) and m), proof of exemption from paying tariffs is provided by presenting the original free passage permits.

5. In order to justify the passage of exempt vehicles, the staff of the Giurgeni Collection Agency has the right to keep a copy of the supporting documents.

6. Fares apply for each crossing, regardless of the direction of travel.

7. The fares for 20 passes are valid for the same type of road vehicle, based on prepaid coupon tickets, valid until December 31 of each year.

8. Rates for 20 passes are valid only for full advance payment.

9. Prepaid coupon tickets will be issued at least at the following work points of the National Road Infrastructure Management Company - SA: Giurgeni Collection Agency , National Roads Section Fetești and Regional Directorate of Roads and Bridges Constanta . Other additional points to those mentioned will be published on the website of the National Company for the Administration of Road Infrastructure - SA

10. The issuance of prepaid coupon tickets is made following the submission of an application by the legal entity or individual requesting prepaid passes, at one of the locations mentioned in point 9.

11. The coupon tickets will be issued within a maximum of 10 working days from the date of registration of the application requesting prepaid passes to one of the locations mentioned in point 9.

12. The model for prepaid coupon tickets, the model for the request for the issuance of prepaid coupon tickets and the procedure for their issuance, management and

control will be established by the National Road Infrastructure Administration Company - SA, through the Constanța Regional Directorate of Roads and Bridges .

13. The model for the request for the issuance of prepaid coupon tickets will be published on the website of the National Road Infrastructure Management Company - SA and the Constanța Regional Directorate of Roads and Bridges .

14. For the civil component provided for in point A letters f)-j)), free passage permits for an indefinite period are issued by the National Road Infrastructure Administration Company - SA Modelul and the conditions for granting are established inter-institutionally . The free passage permits will be cancelled or replaced if the persons no longer benefit from the granted right or the model of the permit is modified.

15. The exceptions to the payment of the toll fee mentioned in point A letter l) are made on the basis of free passage permits, issued for a period of 6 (six) calendar months, personalized with the registration number of the road vehicle owned or used based on a legal riparian right and the validity period.

16. By riparian is meant a natural person whose domicile is located on one side of the Danube and whose workplace/agricultural land is held under a property title on the other side of the Danube and who uses the bridge to travel to/from work/agricultural land - from/to home.

17. The status of a resident is certified based on the domicile address in the identity document and the document issued by the employer, which shows the status of employee, the address of the workplace where the person works. carries out the activity and the period of employment, or, as the case may be, of the document issued by the city hall/local council showing the ownership of agricultural land based on a property title and the location of the agricultural land.

18. The documents on the basis of which the status of river resident is recognized will be presented in Romanian, and in the case of translations, these must be authorized.

19. For each riverside resident, the exemption from paying the toll is granted for a single car owned or, as the case may be, used based on a legal right according to the data entered in the registration certificate or owned by the applicant's spouse and acquired during the marriage.

20. Free passage permits for riverside residents will be issued at least at the following work points of the National Road Infrastructure Management Company - SA: Giurgeni Collection Agency , National Roads Section Fetești and Regional Directorate of Roads and Bridges Constanta . Other additional points to those mentioned will be published on the website of the National Company for the Administration of Road Infrastructure - SA

21. Free passage permits for riverside residents are granted following the submission of an application by the person requesting exemption from paying the passage fee, at one of the locations mentioned in point 20.
22. The application for the issuance of free passage permits for riverside residents must be submitted by the 20th of the month and will be accompanied by the original certificate issued by the employer or, as the case may be, by the city hall/local council, a copy of the vehicle registration certificate/vehicle identity card, a copy of the identity document and , as the case may be, a copy of the marriage certificate.
23. The issuance of the free passage permit and /or the communication of the response, as the case may be, shall be made no later than the last working day of the month in which the complete documentation was submitted .
24. Free passage permits not collected within 45 days from the date of submission of the documents are cancelled, requiring the submission of new complete documentation for the issuance of a new free passage permit.
25. Free passage permits for riverside residents are valid for 6 (six) months, starting on the 1st of the following month in which the conditions for granting the exception are met .
26. The model of free passage permits for riverside residents, the model for the application for the issuance of free passage permits for riverside residents and the procedure for their issuance, management and control will be established by the National Road Infrastructure Management Company - SA, through the Constanța Regional Directorate of Roads and Bridges .
27. The model for the request for the issuance of free passage permits for riverside residents will be published on the website of the National Road Infrastructure Management Company - SA and the Constanța Regional Directorate of Roads and Bridges .
28. The exceptions to the payment of the toll fee mentioned in point A letter m) are made on the basis of free passage permits issued for a period of 12 (twelve) months by the National Road Infrastructure Management Company - SA, through the Constanța Regional Directorate of Roads and Bridges .
29. For each person with a severe or serious disability, an exemption from paying the toll fee for a single car is granted. The car may be owned or, as the case may be, used on the basis of a legal right according to the data entered in the registration certificate by the person with disability or by one of the persons entitled to benefit from the free toll on behalf of the person with disability (spouse , child/parent, siblings).
30. Free passage permits for people with severe or severe disabilities are granted following the submission of an application by the person with severe or severe disability

or by one of the persons entitled to benefit from free travel on behalf of the person with disability, at the headquarters of the National Roads Section . Fetești or the Regional Directorate of Roads and Bridges Constanța .

31. The application for the issuance of free passage permits for persons with severe or severe disabilities shall be submitted by the 20th of the month and shall be accompanied by the "certificate of classification in degree of disability", in a copy conforming to the original, indicating the degree of severe or severe disability, a copy of the vehicle registration certificate/vehicle identity card, a copy of the identity document (birth certificate) of the person with severe or severe disability and a copy of the identity document of one of the persons entitled to benefit from free travel on behalf of the person with disability (spouse , child/parent, siblings), as appropriate.

32. Free passage permits for people with severe or severe disabilities will be issued at least at the following work points of the National Road Infrastructure Management Company - SA: National Roads Section Fetești and Regional Directorate of Roads and Bridges Constanta . Other additional points to those mentioned will be published on the website of the National Company for the Administration of Road Infrastructure - SA

33. The issuance of the free passage permit and /or the communication of the response, as the case may be, shall be made no later than the last working day of the month in which the complete documentation was submitted .

34. Free passage permits not collected within 45 days from the date of submission of the documents are cancelled, requiring the submission of other complete documentation for the issuance of a new free passage permit.

35. Free passage permits for persons with severe or severe disabilities are valid for 12 (twelve) months starting with the 1st of the following month in which the conditions for granting the exception are met .

36. The model of free passage permits for persons with severe or serious disabilities, the model for the application for the issuance of free passage permits for persons with severe or serious disabilities and the procedure for their issuance, management and control will be established by the National Road Infrastructure Administration Company - SA, through the Constanța Regional Directorate of Roads and Bridges .

37. The model for the request for the issuance of free passage permits for people with severe or serious disabilities will be published on the website of the National Road Infrastructure Administration Company - SA and the Constanța Regional Directorate of Roads and Bridges .

38. In the event of a change in the conditions under which the exemption from paying the tariffs was granted, the persons who requested the free passage permits for residents or for persons with severe or severe disabilities are obliged to notify in writing

the National Road Infrastructure Administration Company - SA, through the Constanța Regional Directorate of Roads and Bridges , about the changes that have occurred or the loss of the right to free passage and to hand over the original free passage permit, for cancellation, within a maximum of 5 working days.

39. Failure to comply with the obligations provided for in point 38 will lead to the recovery by the Regional Directorate of Roads and Bridges Constanța , from the persons who benefited from the free service, of the amounts calculated for the period between the date from which the conditions for granting the exception are no longer met and the date of finding that the exception was not met .

40. December 23rd of each year is considered "Bridge Day", when cars can cross without paying a toll.

A. The toll can be paid in cash or by card at the Fetești Collection Agency only on the marginal lanes where there is an operator and barrier, inscribed with the "cash" sign, and only for one toll, with the validity of that toll.

B. Cars owned or, as the case may be, used on the basis of a legal right by persons with severe or severe disabilities or owned by persons entitled to benefit from free access on behalf of the person with severe or severe disabilities who use the marginal lanes of the Fetești Toll Collection Agency where there is an operator and barrier**), inscribed with the "cash" sign, are exempt from paying the toll, subject to the following conditions :

1. exceptions from paying the toll are made on the basis of free passage permits issued for a period of 12 (twelve) months by the National Road Infrastructure Administration Company - SA, through the Constanța Regional Directorate of Roads and Bridges ;

2. For each person with a severe or serious disability, an exemption from paying the toll for a single car is granted. The car may be owned or, as the case may be, used on the basis of a legal right according to the data entered in the registration certificate by the

person with a disability or by one of the persons entitled to benefit from the free toll on behalf of the person with a disability: spouse , child/parent, siblings ;

3. free passage permits for people with severe or severe disabilities are granted following the submission of an application by the person with severe or severe disabilities or by one of the persons entitled to benefit from free passage on behalf of the person with disabilities, at the headquarters of the Fetești Collection Agency or the Constanța Regional Directorate of Roads and Bridges ; other additional points to those mentioned will be published on the website of the National Company for the Administration of Road Infrastructure - SA;

4. the application for the issuance of free passage permits for persons with severe or severe disabilities shall be submitted by the 20th of the month and shall be accompanied by the "certificate of classification in degree of disability", in a copy conforming to the original, indicating the degree of severe or severe disability, a copy of the vehicle registration certificate/vehicle identity card, a copy of the identity document (birth certificate) of the person with severe or severe disability and a copy of the identity document of one of the persons entitled to benefit from free travel on behalf of the person with disability;

5. free passage permits for people with severe or severe disabilities will be issued at least in the following work points of the National Road Infrastructure Administration Company - SA: Fetești Collection Agency and Regional Directorate of Roads and Bridges Constanța ; other additional points to those mentioned will be published on the website of the National Company for the Administration of Road Infrastructure - SA;

6. the issuance of the free passage permit and /or the communication of the response, as the case may be, shall be made no later than the last working day of the month in which the complete documentation was submitted;

7. free passage permits not collected within 45 days from the date of submission of the documents are cancelled, requiring the submission of other complete documentation for the issuance of a new free passage permit;

8. free passage permits for people with severe or severe disabilities are valid for 12 (twelve) months, starting with the 1st of the following month in which the conditions for granting the exception are met ;

9. the model of free passage permits for people with severe or serious disabilities, the model for the request for the issuance of free passage permits for people with severe or serious disabilities and the procedure for their issuance, management and control will be

established by the National Company for the Administration of Road Infrastructure - SA, through the Regional Directorate of Roads and Bridges Constanța ;

10. the model for the request for the issuance of free passage permits for people with severe or serious disabilities will be published on the website of the National Road Infrastructure Management Company - SA and of the Constanța Regional Directorate of Roads and Bridges ;

11. in the event of a change in the conditions under which the exemption from paying the tariffs was granted, the persons who requested the free passage permits for persons with severe or serious disabilities are obliged to notify in writing the National Road Infrastructure Management Company - SA, through the Constanța Regional Directorate of Roads and Bridges , about the changes that have occurred or the loss of the right to free passage and to hand over the original free passage permit, for cancellation, within a maximum of 5 working days;

12. Failure to comply with the obligations provided for in point 11 will lead to the recovery by the Regional Directorate of Roads and Bridges of Constanța from the persons who benefited from the free service of the amounts calculated for the period between the date from which the conditions for granting the exception are no longer met and the date of finding that the exception was not met .

C. Vehicles transporting first aid equipment and humanitarian aid, equipment intended for interventions or vehicles transporting such equipment, within humanitarian missions on the territory of Romania or transiting Romania for humanitarian purposes, at the request of the Department for Emergency Situations within the Ministry of Internal Affairs, based on a collaboration protocol between the two parties , which provides for the working methodology, contact points and the operational communication methods between the two parties .
